Penalty Kicks

<i>Who infringed Law 14?</i>	<i>What was the outcome of the kick?</i>	
	<i>Ball goes into goal</i>	<i>Ball does not go into goal</i>

Questions from 2008 Entry Level Exam to Review

- When an indirect free kick is taken outside the penalty area, the ball is in play when it is kicked and moves.
 - True
- Any player bleeding from a wound must leave the field of play for treatment.
 - True
- At the taking of a throw-in, all opponents must be at least 2 yards away from the point at which the throw-in is to be taken.
 - True
- Players may wear thermal under shorts if they are the same color as the main color of the shorts.
 - True

Questions Continued

- The goalkeeper may participate in a dropped ball restart?
 - Anywhere on the field.
- A field player changes jerseys with the goalkeeper during half-time without informing the referee. When the new goalkeeper touches the ball with his/her hands during the second half, the referee realizes the change. He/she should award a penalty kick for handling the ball within the penalty area.
 - False

Questions Continued

- For the purpose of determining if an attacker is in an offside position, the position of the attacker's head or feet matter, but not the position of the attacker's arms.
 - True
- You stopped the game for an injury that occurred inside the goal area. When you are ready to resume the game, you may restart with a dropped ball from any spot within the goal area.
 - False
- A player who impedes the progress of an opponent, but does not make physical contact, is guilty of an indirect free kick foul.
 - True
- The referee decides that a player is simulating a foul in an effort to fool the referee into awarding a penalty kick. The referee should stop the game, caution the attacker for unsporting behavior and restart the game with an indirect free kick to the defending team.

Answer Choices:

a. Corner Kick b. Goal Kick c. Throw-In d. Dropped ball e. Kick-off

- From a throw-in, the ball went directly into the opponent's goal without being touched by another player.
 - Goal Kick
- A goalkeeper caught and maintained possession of the ball, inside his/her goal area, but injured himself/herself in the process. The referee stopped the game to allow a trainer to attend to the goalkeeper.
 - Dropped Ball
- At a dropped ball, the ball touched the ground and then a player kicked it directly into the opponent's goal.
 - Kick-off

Answer Choices:

a. Corner Kick b. Goal Kick c. Throw-In d. Dropped ball e. Kick-off

- From a penalty kick, the ball rebounds off the goalkeeper back to the player who took the penalty kick. That player then kicked the ball into the goal.
 - Kick-off
- From a corner kick, the ball is properly placed and, as a result of the kick, it immediately leaves the field across the goal line.
 - Goal Kick
- A goalkeeper, while standing in his/her penalty area, attempted to throw the ball to a teammate. The ball rebounded off the referee and went across the goal line near the corner flag post.
 - Corner Kick
- While the ball was in play, the referee temporarily stops the game because of thunder and lightning. After the weather improves and play can be resumed safely, how should the game be restarted?
 - Drop Ball

Questions Continued

- At the taking of a corner kick, opponents are required to be 10 yards from:
 - Corner Arc
- For safety reasons, goals **MUST** be anchored securely to the ground- **TRUE**
- An attacker encroaches into the penalty area on a penalty kick and the ball does not go into the net. The referee decides to restart play with an indirect free kick where:
 - The attacker entered
- “Applying Advantage” is
 - permitting the referee to let play continue when the team against which a foul has been committed will actually benefit from the referee not calling the foul

Offsides

Is the player guilty of offside or not?

- You restart the game with a dropped ball. After it touches the ground, the attacker kicks the ball directly to a teammate who is in an offside position.
 - Offside
- An attacking player, in an offside position, intercepts a pass from a defender intended for that defender's goalkeeper.
 - NOT Offside
- At the moment the ball was played by attacking player # 8, attacker # 11 was in an offside position. # 11 then ran to an onside position where he/she actually received the ball.
 - Offside
- A player takes a shot on goal while a teammate, in an offside position, is blocking the view of the goalkeeper.
 - Offside
- From a shot on goal, the ball rebounds off a goal post to a player, who was in an offside position when the shot was taken.
 - Offside

To Card or Not To Card

- a. Caution and show the guilty player a yellow card.
- b. Send off and show the guilty player a red card.
- c. First show a yellow card and then send off and show the guilty player a red card.
- d. For this incident neither a caution nor a send-off is directed by the *Laws of the Game*.

- A player persistently infringes the *Laws of the Game*.
 - Caution
- A player strikes a teammate.
 - Send Off
- A player tackles an opponent, endangering the safety of the opponent.
 - Send Off
- In the opinion of the referee, a player delays the restart of play.
 - Caution
- While recording a player's information prior to cautioning for a reckless challenge, the referee decides the player is also dissenting from the referee's decision
 - First Yellow card then send-off
- A defender, other than the goalkeeper, while on the goal line, prevents a goal by deliberately handling the ball.
 - Send Off

Restarts

a. Direct Free Kick

- A goalkeeper, standing in his/her own penalty area, struck an opponent, who was outside the penalty area, by deliberately throwing the ball at him/her.
 - DFK
- A player tackled an opponent to gain possession of the ball, making contact with the opponent before touching the ball.
 - DFK
- A player ran between an opponent and the ball so as to slow down the opponent rather than trying to play the ball. No contact was made between the player and the opponent.
 - IFK
- A player prevented an opponent from moving to the ball by holding his/her shirt.
 - DFK

Restarts

a. Direct Free Kick

- A player attempted to punch an opponent, but missed.
 - DFK
- A player correctly threw the ball into play. He/she then ran onto the field to prevent an opponent from intercepting the ball and knocked the ball away with his/her hand. No other player had touched the ball before this action.
 - DFK
- The referee saw a player spitting at a teammate.
 - IFK
- A player with an obvious goal scoring opportunity advances with the ball into the opponent's penalty area. A defensive player throws one of his shoes at the ball. The ball is deflected wide of the goal.
 - PK

Restarts- Part II

a. Corner Kick b. Goal Kick c. Penalty Kick d. Direct Free Kick e. Indirect Free Kick

- While the ball was in play at mid-field, a defender, standing in his/her penalty area, struck an opponent.
 - PK
- At the taking of a penalty kick, a defender entered the penalty area before the kick was taken. The goalkeeper deflected the kick over the crossbar.
 - PK
- A corner kick is about to be taken. Before the kick is taken, a defender pushes an attacking player in the penalty area.
 - Corner Kick
- A defender tackles the ball away from an opponent near the goal line. He/she then passes the ball forwards to his/her goalkeeper who is running back from outside the penalty area. The goalkeeper, still outside the penalty area, now picks up the ball.
 - DFK
- At the taking of a penalty kick, the kicker commits an infraction after the referee signals but before the kick was taken. The kick was taken and the ball went 5 yards wide of the goal.
 - IFK

Restarts- Part II

a. Corner Kick b. Goal Kick c. Penalty Kick d. Direct Free Kick e. Indirect Free Kick

- While the ball was in play in his/her penalty area, a player deliberately punched an opponent near the halfway line.
 - DFK
- A goalkeeper, standing inside his/her penalty area, violently threw the ball at an opponent who was standing outside the penalty area.
 - DFK
- A defender (NOT the goalkeeper) while in his/her penalty area, purposely used his/her hands to prevent the scoring of a goal. The ball was deflected out of play over the goal line, but did not enter the goal.
 - PK
- At the taking of a penalty kick, the kicker approached the ball to kick it, but slipped and fell on the wet grass. He/she barely managed to kick the ball forward. An alert teammate, who had been standing just outside the penalty arc, ran up and kicked the ball across the goal line but not into the net.
 - Goal Kick

Things to Know

- Never show a card to a coach
- AR closest to injured player helps with injuries
- Caution a player who takes his/her shirt off
- Deliberate pass back to keeper-IDK
- Drop Balls between any # of players
- A little stutter step is allowed on a PK
